Dear Mr. Baiter:

Pursuant to California and federal law, I am notifying you that various organizations within AT&T will be eliminating 74 jobs at 2600 Camino Ramon, San Ramon, California. Set out below is a breakdown of that number.

AT&T Global Customer Service

AT&T Global Customer Service will be eliminating 72 non-management positions at 2600 Camino Ramon, San Ramon, California.

The elimination of these jobs at 2600 Camino Ramon, San Ramon, California is expected to be permanent and employees do not have the right to bump another employee out of his or her job.

Three employees were notified of their surplus status on December 15, 2014. The process outlined in the 2012 Collective Bargaining Agreement between the Company and the Communications Workers of America has been and will be followed. This includes opportunities for employees to voluntarily elect to leave employment with severance benefits. The separation process for non-management employees who do not elect to leave with severance benefits will continue until each affected employee has been given at least one job offer for another position and an opportunity to accept or reject that offer. All nonmanagement employees who accept such a job offer will not be terminated. If an employee declines a job offer in a category specified in the Collective Bargaining Agreement, starting April 13, 2015, the employee will be removed from the payroll.
